#### MEETING CONCLUSIONS

- 6. The following statement was agreed by Members and complements Article 2 although it is not included directly in the document: "The Chairperson shall ensure that the IRSG agenda constitutes an adequate balance of different topics, so that, overall, the agenda offers a topic for discussion by, and of interest for, every stakeholder category, thus, ensuring their proportionate participation in the IRSG discussions. This should also ensure and active and proportionate engagement in the IRSG work by any stakeholder category.
- 7. Members approved the IRSG Rules of Procedure (<u>IRSG-20-25</u>) with the above addendum.

## AGENDA ITEM 05: Election of the IRSG Chair and Vice Chair

8. Candidates explained their motivation and EIOPA staff explained the voting modalities.

## CONCLUSIONS AND ACTION POINTS

9. Michaela Koller was elected as IRSG Chairperson by simple majority. Paul Fox accepted EIOPA Chairperson's nomination to act as Vice Chairperson and was approved by consensus by the IRSG.

## AGENDA ITEM 06: EIOPA DISCUSSION PAPER ON (RE)INSURANCE VALUE CHAIN AND NEW BUSINESS MODELS ARISING FROM DIGITALISATION

- 10. EIOPA presented its recent public consultation on digitalisation and the fragmentation of the insurance value chain, which runs until 7 September.
- 11. Members briefly discussed the critical importance of these issues, including the development of platforms and eco-systems, the importance of ensuring a level playing field, of considering a wide range of use cases and examples, and of looking to impacts in view of longer term business.

## CONCLUSIONS AND ACTION POINTS

- 12. IRSG member Marcin Kawinski volunteered to lead this new work stream. Pierpaolo Marano as well as Monica Calu and Martin Schmalzried indicated their interest in participating to this work stream.
- 13. Members can volunteer until 6 August 2020 via the <u>IRSG Work Plan</u> document to partipate in the drafting team for this consultation.

## **AGENDA ITEM 07: Solvency II holistic impact assessment**

14. EIOPA staff presented [link\_to presentation] its preliminary results from the information request for the holistic impact assessment, and addressed the impact of the covid19 crisis on the timeline of the Solvency II review. Members reacted to the presented and exchanged further views.
