1. INTRODUCTION

EIOPA has prepared this statistical annex from a survey conducted with NCAs to assess the availability of the pensions data in their market. The survey built on the Database of Pension Plans and Products¹. This database provides a comprehensive snapshot of the European pensions' landscape and helps to better understand pension systems in Europe. The Database has been prepared by EIOPA on a best effort basis, with contributions from NCAs. Adjustments and simplifications were applied both in defining characteristics of plans and products and in providing the information by the authorities.

NCAs were recommended to collaborate with other entities in their countries to check the pension data availability. However, not all were able to do so in the short timeframe given, while it remains a possibility that information is available in a country without the NCA having access to it. Therefore, this statistical annex should be considered best effort to assess the data availability and not be interpreted as a fully complete, "official" list of all available information on pension plans or products in EEA.

The survey made a split between occupational and personal information as well as between DB and DC schemes. Products were also split in three categories of providers: IORPs, insurance undertakings and other entities not subject to Solvency II or the IORP Directive. The data was presented both as the ratio of the availability of the products over the total number of products in a particular category as well as the ratio of the assets reported over the total assets reported in a particular category.

N/A represents that either no products exist in a particular category in a certain country or that no assets were available and, as such, not reported in the Database. Asset data on IORPs could be estimated based on the reporting of IORPs data to EIOPA. However, in a number of cases multiple products with similar characteristics exist in the Database on Pension Plans and Products. In such cases, the assets were equally divided over the respected products.

The IORP sector includes contractual pension funds, open pension funds with collective adhesions and the old contractual pension funds. IORPs are almost all DC; residual DB IORPs are related to old contractual pension funds which are closed to new adhesions.

24. NETHERLANDS

OVERAL PICTURE

In the Netherlands data availability related to occupational pensions provided by IORPs is high, but there's no possibility to split these data between DB (the most common arrangement so far) and DC plans. NOTES ON THE DATA INCLUDED IN THE DATABASE

Sweden finalised the IORPII legislation in January 2020. The entities have to be authorised¹ by Finansinspektionen to apply the new occupational rules and regulation. By the end of 2020 Sweden had one transformed IORP and by the end of 2021 there is a total number of nine IORPs. There is also a delay in the reporting due to the fact that the entities have to be transformed and applying the new legislation before they are included of the reporting requirements. The new legislation has made it possible for life insurance companies providing occupational pensions, to apply for authorisation as an occupational pension undertaking. Traditionally occupational pensions have been mainly provided by life insurance companies and SE envisages a shift in the market from life insurance companies to occupational pension undertakings.
