General Comment	We consider that there is value in having guidelines which require national competent authorities to operate a pre-application process and which provide a framework for the functioning of colleges in the pre-application process.	
	We see no value in guidelines which effectively replicate rules contained in the Draft Level 2 text. Such guidelines will either be a faithful restatement of the Level 2 rules, in which case they are redundant, or they will be different, in which case they will cause confusion and may breach the fundamental principle that Level 3 guidance must not extend the scope of Level 2 rules. As an example we would point to Guideline 57 on the user manual which introduces a criterion for internal model documentation which is inconsistent with that in the Level 2 text. Accordingly, guidelines 4 to 67 should be omitted.
