	Bermuda note the progress that has been made and recognize the current focus of the Bermuda Monetary Authority ("BMA") on the outstanding matters, notably relating to public disclosure and the Economic Balance Sheet (EBS).	
	Our members highlight the exceptional job that the BMA has undertaken in developing a modern and robust regime, already recognized by the US National Association of Insurance Commissioners ("NAIC") as a Qualifying Jurisdiction and which, it would appear, is making significant strides towards being acknowledged as equivalent to the Solvency II regime. The BMA has developed a sound and competitive regime that attracts a supply of capital that ultimately provides (re)insurance policyholder protection and delivers value to policy holders as well as to ceding companies and their underlying assured.	
	We note the recently issued BMA EBS consultation paper and draft legislation, intended to be implemented prior to the effective date of Solvency II, is consistent with the discussions that we have been having with the BMA on the Economic Balance Sheet and on public disclosure of GAAP financials and can attest to the determination and vigor with which full implementation is being pursued. We note the enabling legislation for the requirement for public disclosure of GAAP financials by Class C and D insurers was passed in 2012.	
	The field testing for the Economic Balance Sheet is an important next phase, particularly for the long-term sector, consistent with experience and debate in Europe.
