- The need for proportionate measures, in line with the Pan-European Personal Pensions (PEPP) Regulation, to minimise the administrative burden was confirmed.

• MB discussed the issue of the threshold of 1:1 ratio between fixed and variable remuneration as a trigger for supervisors to engage with the undertakings and agreed to make it clearer in the text that the threshold should not in any case prevent the supervisors to adopt a lower one.
