# **Executive Summary**

The document provides an overview of the EIOPA Budget 2020 adopted by the Board of Supervisors on 30 January 2020. It is divided into revenue, expenditure, the overview by titles and the establishment plan 2020.

#### 1. EIOPA Budget Revenue 2020

Contribution from the European Union (40%) including surplus	10,804,000
Contribution from National Competent Authorities (NCA) (60%)	16,206,000
EFTA contributions on top of NCA contributions	460,398
Pensions contributions (comprised of NCA and EFTA contributions)	1,600,000
Other revenues (administrative agreements)	350,000
TOTAL REVENUE	29,420,398

The European Union grants EIOPA a subsidy of 40%. The remaining 60% are contributions from the Member States. The individual Member States contributions are calculated according to the weighting of votes set out in Article 3(3) of the Protocol (No 36) on transitional provisions<sup>1</sup>. In addition, since 2016 the Member States and EFTA states pay the 'employers contributions to the EU pensions' scheme in accordance with Article 83a of the Staff regulations<sup>2</sup>. EFTA states pay their contributions according to the weighting factor<sup>3</sup> on the top of the Member States contributions.
