	to policyholders. Secondly, many European insurers, especially in the London Market, are in some form of group relationship with Bermudan (re)insurers. Equivalence will allow groups to manage their risks more holistically. Similarly, it will encourage a more consistent dialogue between insurers and regulators throughout a group. Equivalence will also prevent a short term market dislocation, given the volume of business transacted between Europe and Bermuda. The risk is that if Bermuda does not have equivalence, there will be short term uncertainty over risk mitigation strategies, which may lead to other risks receiving less attention than they merit. The Bermudan market is well developed and trusted by insurers. We are pleased that the efforts the BMA hae made have been recognized. There is also benefit to having risk ceded outside the EEA, as in the event of a major European catastrophe, a significant proportion of the funding required in its aftermath would come from outside the affected economies.
