6.1. Solvency II 2020 Review

6.1.1. Review of Solvency II: Highlighted issues

Type: Discussion

Voting results: Not applicable

Conclusions:

 MB agreed to proceed in discussions with BoS in view of the highlighted topics of extrapolation of Risk-free Interest Rates; Volatility Adjustment; and Matching Adjustment.

6.1.2. Reporting and Disclosure Consultation Paper

Type: Discussion

Voting results: Not applicable

Conclusions:

- MB agreed that the Reporting and Disclosure Solvency II Review 2020 package is a good basis for discussion at BoS and that the message should be that the reporting package needs to be streamlined overall.
- MB agreed that captives are an area where further work is needed in light of proportionality both in reporting and disclosure.
- MB agreed that the package is a good basis for the consultation but specific areas might need further thought after consultation such as the level of granularity of cyber template or internal models information.
- MB supported the 'Two-pages' Solvency and Financial Condition Report for policyholders with clear and easy to understand language.

Action points:

- EIOPA to include in the Impact assessment an overall view of the overall effect of the changes proposed to illustrate whether they lead to simplification of the overall reporting package.
- EIOPA to follow up with COM on the discussions from the past regarding

empowerment of the Implementing Technical Standard regarding materiality, proportionality and risk-based thresholds.

- EIOPA to reflect in the package further proportionality regarding captives.
- EIOPA to follow up, during the consultation period, with the Internal Model Forum on the proposals regarding Internal Model reporting.

- Members committed to the negotiations resulting into an ICS 2.0 by the end of 2019.
- MB confirmed to evaluate the US Aggregation Method (AM), by the end of the monitoring period, based on quantitative indicators but also supported to complement it with qualitative requirements. Members also supported a roadmap regarding the assessment of AM and the criteria to be applied, including milestones, to be proposed by the International Association of Insurance Supervisors (IAIS) by the end of 2019.

- MB welcomed the Consultation Paper and concluded that good progress had been made on the topic in line with the steering of BoS in March 2019.
- MB agreed that EIOPA should follow a step-by-step approach on this topic and keep the momentum. Therefore, feedback from stakeholders should be gathered at this stage before continuing working out the technical details.

- EIOPA to present the findings of the thematic review at the BoS in June 2019 for a strategic discussion on the possible supervisory follow-up.
- CCPFI to finalise the report with a target of the CCPFI 3 July 2019 meeting, to be followed by a potential written procedure on the final report with the Board.
